PUG RESCUE RELEASE FORM

TERMS OF RELEASE

I hereby acknowledge the following terms and conditions for releasing this dog into the custody of the **Pug Dog Club of BC**, in order that it may be placed in a desirable home, and;

1. The owner or person who is releasing the dog named above to **the Pug Dog Club of BC** has made a good faith attempt to contact the breeder of the dog to determine whether the breeder will accept the return of the dog, and
2. The owner of the dog named above releases full rights, ownership of, and beneficial interest in the dog to **the Pug Dog Club of BC**, with full authority to sell or place this dog in another home, and
3. The releaser of the dog above gives full authority to **PDCBC RESCUE** for any veterinarian treatment or health care needed by the dog above, and acknowledges that the expenses for such care will come out of the money recovered for the dog, Therefore the owner or agent has agreed to disclose any health condition affecting the dog that they are aware of, prior to the date of the release, and
4. Under no conditions will the owner or agent releasing the dog learn the identity of the new owner of the Pug, and **the Pug Dog Club of BC** is under no obligation to provide such information, and
5. The releasers agree to absolve the **Pug Dog Club of BC** from any responsibility for the loss, injury, or death of the dog which might occur to the dog while in the care of the PDCBC or the new Adoptive owners.

I/we hereby declare that I/we are the sole and rightful owners of the above dog or the authorized legal agent of the owner, and that no other person has an ownership or beneficial interest that may be affected by the release of the dog or transfer of ownership to another person.
